Board Meeting Minutes May 28, 2020

ANNOUNCEMENTS & OTHER BUSINESS FOR FUTURE MEETINGS:

Chairman Bendfeldt asked if there were any announcements or suggestions for future meetings. There were none.

EXCUSED ABSENCES: There were none.

FINANCIAL REPORT: Jay Richeson made a motion to approve the May financial report as presented. Alicia Haussler seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

COST SHARE PROGRAMS: Transfer & Applications – Kelly Cole, Administrative Assistant, requested a transfer of \$2,000 from Tree Planting Cost Share to Streambank Stabilization Cost Share and reported that we have received cost share applications for the following programs: Streambank Stabilization, Tree Planting and Well Decommissioning (see enclosed). She said the applicants are in compliance with the District's rules and regulations, funds are available, and she recommended they be approved.

Alicia Haussler made the motion to approve the cost share transfer and applications as reported. Deb VanMatre seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

BUDGET COMMITTEE MEETING: Committee chairman Jim Bendfeldt reported on their meeting held earlier that day. The committee reviewed the entire budget. The budget is on Dropbox for everyone to review. The budget committee will bring the entire budget to the board next month.

PLAUTZ VIEWING DECK UPGRADE: Assistant Manager, Jesse Mintken, reported that Central Platte NRD received two RFP's for the Gibbon Crane Deck. The RFP's were received from Miller & Associates and JEO Consulting. After reviewing, staff's recommendation was to go with JEO Consulting.

Alicia Haussler made the motion to accept the proposal from JEO Consulting for the Plautz Viewing Deck Upgrade. Jay Richeson seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

UNL TAPS SPONSORSHIP REQUEST: Manager, Lyndon Vogt, reported that Central Platte NRD has supported the TAPS programs that last two years at the rate of \$1,000 per year. Dean Krull has a team this year, with a couple staff members assisting him.

Alicia Haussler made a motion to sponsor TAPS at the rate of \$1,000. Lon Bohn seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

MANAGER'S REPORT: Manager, Lyndon Vogt, reported that Central Platte NRD full staff will return back to the office June 1, 2020. Staff will have a protocol to follow to keep everyone safe. Doors will remain locked to the public. However, staff will take appointments as needed and collect paperwork from landowners stopping at the NRD office.

A new employee, Brody Vorderstasse, Communications Assistant, will begin June 1, 2020. This position is shared with the RWBJV and the NRCS.

Last month Central Platte NRD filed cease & desists on 94 producers. As of today, May 28, 2020, only 18 are out of compliance. Water Quality Programs Assistant, Tricia Dudley has had contact with the remaining 18 producers that are out of compliance.

Recent rain fall for our entire district was between 5-11". Flooding was very similar to last March. The ground was so saturated, and our water table was so high, that the majority of the water ran off. The hardest hit area of the Central Platte NRD appears to be in Merrick County.

Our detention cell at Prairie/Silver/Moores is about one-third full, it handled the heavy rain very well. The detention cell is releasing water through two gates, in which one cannot be closed and releases about 80-100 cfs. The other gate is completely closed at this time.

TREE/WEED BARRIER SALES: Administrative Assistant, Kelly Cole, reported on the recent sales of trees and weed barrier (see attached).

UPCOMING EVENTS: Next Board Meeting – Scheduled for the afternoon of Thursday, June 25. Details to follow.

UPCOMING EVENTS: Chairman Bendfeldt reviewed the upcoming events.

OTHER BUSINESS: Assistant Manager, Jesse Mintken, reported that the Corp of Engineers has published our LOMR for the Prairie/Silver/Moores project. There is still a 90-day period for public comment. We are expecting new flood maps to take effect in September 2020. As a result of the new flood maps this will take a good portion of northwest Grand Island and approximately 10,000 acres of farm ground out of the 100-year flood zone.

ADJOURN: Chairman Bendfeldt adjourned the board meeting at 2:32 p.m.
