<u>Dewatering Well Permit:</u> This permit is approved with the understanding that the landowner will agree and abide by the following conditions:

- 1. All city, state and federal regulations and requirements must be followed.
- 2. If the proposed Dewatering Well is within the city limits, approval from the city will be required and a written copy of that approval will need to accompany this permit application.
- 3. Discharge water cannot be pumped onto another landowners property.
- 4. If a well is not constructed within a one-year period from the date of approval, a new permit is needed.
- 5. According to Neb. Rev. Stat. § 46-673, water wells may not be drilled within 50 feet of a stream bank without first getting a surface water right for that stream from the Nebraska Department of Natural Resources.
- 6. Permits are not required for test holes, temporary dewatering wells (less than 90 days), or wells designed to pump 50 gallons per minute or less. *If possible, mark (with a flag) the well site in the field.*
- 7. This permit does not register the well with the Nebraska Department of Natural Resources. All wells are required to be registered with the Department within 60 days after the well is completed.

The Rules and Regulations of the Temporary Suspension of Groundwater Wells and the above Conditional Use Permit will be enforced by the District with cease and desist orders issued in Accordance with the Rules and Regulations for the enforcement of the Groundwater Management Plan adopted July 23, 1987, and subsequently amended.

In accordance with Neb. Rev. Stat § 46-656.10, any person who violates a cease and desist order issued by the district shall be subject to a civil penalty of not less than one thousand dollars and not more than five thousand dollars for each day an intentional violation occurs.

I have read and understand that in order to obtain this well permit, drill the supplemental well, and use the supplemental well, I must comply with Central Platte Natural Resources District's Rules and Regulations of the Temporary Suspension of Groundwater Wells, which includes the condition stated above.
