Board Meeting Minutes April 28, 2022

CALL TO ORDER: Chairman Mick Reynolds called the meeting to order at 2:00 p.m. He reported that the NRD abides by the Open Meetings Act in conducting business and said that a copy of the Open Meetings Act was displayed on the south wall of the conference room, that the Board reserves the right to change the order of an item on the agenda, and some items on the agenda are subject to closed session.

MEETING NOTICES: Chairman Reynolds reported that the notices of the meeting had been published in the Grand Island Independent and the news release was provided to other media outlets in the District.

MEETING MINUTES: Alicia Haussler made the motion to approve the March board meeting minutes. Tom Downey seconded the motion. All board members present, voting by roll call vote, were in favor, except Jim Bendfeldt who abstained. Motion carried.

ANNOUNCEMENTS & OTHER BUSINESS FOR FUTURE MEETINGS:

Chairman Reynolds asked if there were any announcements or suggestions for future meetings. There were none.

PUBLIC FORUM: Chairman Reynolds asked if anyone wanted to address the board on

any item not included on the agenda. There were none.

EXCUSED ABSENCES: Chairman Reynolds reported that Lon Bohn, Brian Keiser, Keith Ostermeier, Doug Reeves, Marvion Reichert and Ed Stoltenberg requested to be excused from the board meeting.

Jim Bendfeldt made the motion to approve the absences as requested. Alicia Haussler seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

JEO CONSULTING GROUP UPDATES – LOWER WOOD RIVER & ELM/TURKEY CREEK WATERSHED DESIGN PLANS: John Peterson, JEO Project Manager, reported to the board that the Elm/Turkey Creek WFPO and Lower Wood River WFPO are 60% completed with the studies. They reviewed possible solutions to reduce flood risks for each project.

The Lower Wood River WFPO potential projects are all over \$25 million, which exceeds the limit for the WFPO and would require congressional approval. An NRCS letter to request additional funds and time to transition the Lower Wood River WFPO from an Environmental Assessment (EA) to an Environmental Impact Statement (EIS) was recommended. With this change, the EIS would look at the Upper Wood River Watershed as well, doubling the size of the study area.

Jim Bendfeldt made a motion to request additional funds and time from NRCS to transition the Lower Wood River WFPO from an Environmental Assessment (EA) to an Environmental Impact Statement (EIS). Tom Downey seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

NRCS REPORT: Janelle Taubenheim, Kearney NRCS Resources Conservationist, reported on new staff in the Kearney office and the Forest Stand Improvement Projects in Buffalo County (see attached).

EASTERN PROJECTS: LeRoy Arends, acting chairman, reported that the Eastern Projects Committee met earlier today.

Arends reported that we received a request from Summit Carbon Solutions on acquiring an easement on a piece of property we own in Merrick County to install a carbon dioxide pipeline. They are requesting 2.625 acres located in Section 15-13N-06W, which is currently a Wetland. The easement will be 50ft, 25feet in each direction from the center line. A payment of \$17,277.00 will be made to the Central Platte NRD for the easement.

LeRoy Arends made a motion to approve an easement of 2.625 acres located in Section 15-13N-06W to Summit Carbon Solutions to install a carbon dioxide pipeline. Alicia Haussler seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

Arends reported that Hall County has requested a change to the Platte Valley Industrial Park Drainage Agreement. Amendment #1 will allow Hall County to replace their inkind services with funds from the American Recovery Plan Act (ARP) and all easement negotiations will go through the Central Platte NRD.

LeRoy Arends made a motion to approve Amendment #1 for the Platte Valley Industrial Park Drainage Agreement, which will allow Hall County to replace their in-kind services with funds from the American Recovery Plan Act (ARP) and all easement negotiations will go through the Central Platte NRD. Alicia Haussler seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

Arends reported that the Eastern Projects Committee reviewed the proposed 2023 Fiscal Budget and recommended we move it onto the Budget Committee.

PROGRAMS COMMITTEE: Deb VanMatre, chairman, reported that the Programs Committee met earlier today.

VanMatre reported that we received an Urban Conservation Application from the Lexington Patriot Park and Pond in the amount of \$40,000.00. This application was to construct a 1.4-acre groundwater fed pond with a municipal park.

Deb VanMatre made a motion to approve the Urban Conservation application for the Lexington Patriot Park and Pond in the amount of \$40,000.00. Jay Richeson seconded the motion. All board members present, voting by roll call vote, were in favor. Motion carried.

VanMatre indicated that the committee will review our current Urban Conservation Assistance Program and its priorities and may bring changes to the board to approve.

VanMatre reported that we received 3 scholarship applications for the Ron Bishop Memorial Scholarship. The applicants meet all the requirements.

Deb VanMatre made a motion to approve 3 Ron Bishop Memorial Scholarships in the amount of \$1,000 each to Michael Steele of Ravenna, Ty Swanson of Wood River and Mitchell Miller of Kearney. Alicia Haussler seconded the motion. All board members, voting by roll call vote, were in favor. Motion carried.

VanMatre also reported that the committee reviewed the 2023 Cost Share Budget and the 2023 Information/Education Budget and recommended we move it to the Budget Committee.

WESTERN PROJECTS: Ryan Kegley, chairman, reported that the committee reviewed the 2023 Western Projects Budget and recommended we move it to the Budget Committee.

WATER QUALITY & WATER UTILIZATION COMMITTEES: Mick Reynolds, chairman, reported that the committee reviewed the 2023 Water Budget and recommended we move it to the Budget Committee.

SUBDISTRICT COMMITTEE REPORT: No Report.

VIOLATIONS REPORT: Luke Zakrzewski, GIS Image Analyst, reported that of the 50 violation letters that were sent out February 18, 2022, 29 have been resolved. The remaining 21 have all been in contact and have up until May 13th to get in required paperwork. Landowners Richard Urban of Polk County and Chad Robinson of Dawson County that were issued Cease & Desist orders have both been in contact and are working to resolve violation.

Tricia Dudley, Water Quality Programs Specialist, reported that of the 162 letters that were sent out last month to producers that were out of compliance with the Nitrogen Groundwater Management Plan, 53 still have not come into compliance. Dudley is requesting that we issue Cease & Desist orders to those 53 producers.

COST SHARE PROGRAMS: Applications –Kelly Cole, Administrative Assistant, reported that we have received cost share applications for the following programs: Soil Moisture Sensor and Well Decommissioning (see attached). She said the applicants are in compliance with the district's rules and regulations, funds are available, and she





Forest Stand Improvement Projects

- Buckthorn
- Common buckthorn is found in oak forests, savannas, prairies and riparian woods
- It completely eliminates plant diversity in the understory over time.
- Common buckthorn has a broad environmental tolerance. It leaf's out very early and retains its leaves late into the growing season, giving them a longer growing season than native plants.
- The dense shade, eliminates regeneration of tree seedlings and understory species.
- Allelopathic; produces chemical compounds that inhibit the growth of other vegetation.
- It thrives on well-drained soils.
- Seeds have a laxative effect on birds, aiding in seed dispersal.
- Common buckthorn is the overwinter host for the soybean aphid
- In some states it is on the restricted noxious weed list






Buffalo County Projects

April Report to CPNRD

The Natural Resources Conservation Service (NRCS) recently held their FY2023 Local Working Group (LWG) meeting. The Local Working Group recommends to the NRCS State Conservationist how conservation programs like the Environmental Quality Incentives Program (EQIP) would be used most effectively in their area. The local work group does this by evaluating and prioritizing the resource concerns through their Natural Resource District. These recommendations can include special target areas, cost share rates, which conservation practices should have cost assistance, or how many dollars could be needed. This work group allows local input into how Federal dollars are spent in their area and across the state. I have listed below some of the LWG recommendations from this year's meeting.

- After reviewing our current ranking pools available to producers in the Central Platte, the recommendation was to continue with all the current pools we have available.
- Demand for financial assistance has remained high relative to availability of funds, so the recommendation was to review payment rates, review the bills we collected, and submit adjustments to the cost share rates on commonly used practices. The intent of these gradual adjustment in some payment rates will help to provide more access to the available funds.
- We also reviewed how available funds are being allocated between the different funding pools both State and local, to ensure a good balance exists to address the current resource concerns.
 This was done much like I do at the September Board meeting with all of you, when we review contracts, practices, and the acres treated across the Central Platte NRD boundary.

In conclusion, the Local Work Group has reviewed and discussed the local priorities within our Natural Resources District, and agree we are still doing a good job of addressing the priority resource concerns with the tools in place. It was also discussed that as NRCS staff we are still working through changes and/or new programs that have come with the 2018 farm bill. Examples would be the changes to the RCPP agreements, software issues we are still dealing with regarding the new planning and ranking tool that was released in 2020.
